

Trading Rules Notification Form

ON GROUPING OF STOCKS TRADED ON THE ISE

- Resolution on “***Grouping of Stocks Traded on the ISE***” as announced by the CMB on 23 July 2010, will become effective on 1 October 2010 Friday.
- Grouping of companies within this context will be announced by the ISE on 30 September 2010 Thursday.
- All companies newly offered to public will not be subject to this practice for three months.
- This practice covers only the shares traded on the ISE Equities Market, and does not cover the shares of companies in ISE Emerging Businesses Market opened for SME companies.
- Participation certificates of exchange-traded funds are outside the scope of this practice.
- Stocks in groups B and C will not be subject to margin trading. Margin trading covers both margin purchases and being used as margin.
- Stocks in groups B and C will not be subject to short sale.
- Existing credits related to stocks in groups B and C which had previously been subject to margin trading will be liquidated within 3 months, in line with rules on liquidation of shares excluded from ISE's existing margin list.
- One of the criteria used in determination of company lists in this application is "ratio of shares in actual circulation (RSAC - FDPO)". RSAC will be updated by Central Registration Institution (MKK) each week as of 1 October 2010, and published on MKK web page.
- Basic criteria for determination of companies to be included in group B or C are set as;
 - Publicly traded market value (considering the shares in actual circulation),
 - Number of shares in actual circulation (NSAC),
 - Ratio of shares in actual circulation (RSAC),
 - Being traded on the Watchlist Companies Market,
 - For investment trusts; market price being 1,5 or 2 times the unit share value.

- For stocks in groups A, B and C, automatic session cease and automatic gross Settlement, rules of which will be set by the ISE, will step in as of the beginning of 2011.
- For those who will trade for the first time in shares of companies in group B or C;
 - Will be informed at least once by each brokerage house on trading rules until the end of 2010, when they trade for the first time on shares in groups B or C.
 - As of the beginning of 2011, such acknowledgement will be done at least once on the basis of each share in groups B or C (security, board).
 - All such information will be done using the “**Trading Rules Notification Form**” and such form will contain the trading rules of groups A, B and C. That is, each brokerage house will have to notify the investors trading in shares in groups B or C, on trading rules of A, B and C.
- In accordance with ISE regulation, investment trusts with a market capitalization is below 10 million TL will be traded using single price system, except for those trading with a market maker. This rule will also step in as of 1 October 2010 (Ruling of ISE number 329).
- Transition among groups A, B and C is possible within the framework of the criteria.
- Companies in groups A, B and C will be updated by the ISE in quarterly intervals (1 October - 1 January - 1 April - 1 July, if such dates corresponding to a holiday, following business day will be considered).
- Period of the data set to be used in updates will be determined by the ISE.
- Summarized table on determination of shares in groups A, B and C according to the determined criteria is given below. “**Trading Rules Notification Form**” to be notified to investors must contain, at minimum, the information on such summarized table.
